1. Indian Port Rail & Ropeway Corporation Ltd., (IPRCL) having its Corporate office at 4<sup>th</sup> Floor, Nirman Bhavan, Mumbai Port Trust Building, M. P. Road, Mazgaon (E), Mumbai- 400010, an SPV set up under Ministry of Ports , Shipping & Waterways, as a Joint Venture Company between the Major ports under the Ministry of Ports , Shipping & Waterways and Rail Vikas Nigam Ltd. under Companies Act 2013, invites bids under single stage two packet system for the work of “MODERNIZATION AND UP-GRADATION OF CHENNAI FISHING HARBOUR AT KASIMEDU, CHENNAI – PACKAGE V Part A WORKS”

3. Bids must be accompanied by a Bid Security of required amount in any one of the forms as specified in the bidding documents and shall have to be

valid up to 06-05-2025. Bidder has to select the payment option as “Online mode or Bank Guarantee” to pay the EMD as applicable and enter details of the instrument. In case of Bank Guarantee, scanned copy of BG should be uploaded along with bid. The original Bank Guarantee should be delivered in person/should be received by post to the official nominated as indicated in the Bid Data Sheet within 5 working days of deadline of submission of bids. Delay in receipt of original BG by the post will not be responsibility of IPRCL. Non-submission of scanned copy of Bank Guarantee with the bid on e-tendering portal and/or non-submission of original Bank Guarantee within the specified period shall lead to summary rejection of bid. The details of the BG physically submitted, should match with the details available in the scanned copy and the data entered during bid submission time, failing which the bid will be rejected.

4. Bidding Documents can be downloaded from E-tendering portal of [www.etenders.gov.in](http://www.etenders.gov.in) w.e.f. 17.30 Hrs. of 28/ 10 /2024. The bidder who submits the bids on downloaded tender document will also have to pay the tender fee as mentioned in above table. Please note that drawings, if any, referred in the bid document, but not uploaded with the bidding document, can be viewed in this office on any working day. The Tenderer can also purchase physical bid document on payment of non-refundable cost mentioned above by a crossed Demand Draft on any Scheduled bank payable at Mumbai drawn in favour of Indian Port Rail and Ropeway Corporation Limited, Mumbai from the project office address as correspondence, which is given in Bid Data Sheet.

It will be the responsibility of the bidder who is submitting the bid on downloaded bidding documents to check and see any Addendum/Corrigendum issued in this regard from the website from time to time and ensure submission of bid along with all Addendum/Corrigendum.

5. **Purchase Preference to Make in India:** The provisions of revised ‘Public Procurement (Preference to Make in India) Order 2017’ issued by Department of Industrial Policy and Promotion under Ministry of Commerce and Industry vide letter no. P-45021/2/2017-PP (BE-II) dated 16.09.2020, and as per amendment issued time-to-time up to 28 days prior to deadline for submission of bids shall be applicable. Purchase preference shall be applicable to the bidding process and award of the contract shall be done as per clause ITB 34.
